- 1. Are there 4 full-time employees? Is that appropriate? No answer currently.
- 2. Please explain the taxes cited that benefit the Rec District. Patrick provided an explanation of tax revenue that comes to the Rec Center from residents in Southern Valley Rec District.
- 3. Asked about residents in Donnelly using Southern Valley Recreation District vs. Northern Valley. There is currently no other Valley County Recreation District.
- 4. Has Rec District ever operated in the black? 2021 and 2022. Monica commented on deferred maintenance in the past that is now 'catching up' with the current budget.
- 5. What are plans for achieving operating in the black? Patrick referred to models already shared.
- 6. Do your future projections include the newly approved 1600 homes in the recreation district? Patrick is waiting for platting documents from the County. Larry commented that nontax paying residents may convert to paying members and provided additional commentary on current needs, efforts, board challenges.
- 7. Do back taxes flow into SVCRD once paid? Yes.
- 8. Were these numbers impacted by the status of specific current or former employees? No.
- 9. Are these projections before or after a specific employee was terminated? Non-specific to any employee.
- 10. Are other rec centers self-sufficient? Patrick used local examples to demonstrate self-sufficiency of SVRD programs.
- 11. Are we using volunteers for programs? Yes.
- 12. Do you still write grants and use sponsors? Yes.
