Contractor gave an estimate of \$1200-\$1500 per break in the sub-deck Pex pipes, which includes deck repair and concrete. Facility Manager reported up to 20 breaks are possible at this point. Contractor suggested putting glycol in lines in lieu of water for warming. Maintenance has identified 2-3 of the worst breaks to try spot fixes on soon.
